This Statement defines what cookies are, what cookies we use and how you can control their use.

What Are Cookies?

Cookies are harmless small data files stored on your computer or mobile device when you visit a website that uses these files.

Cookies can be categorized, for example, by the length of time they are stored on an end device (session cookies, persistent cookies) or by the domain with which they are associated (first-party cookies, third-party cookies).

Session cookies are cookies stored in temporary memory and are deleted when the web browser is closed.

Persistent cookies are cookies that expire within a specified time or after specified time has elapsed. They can be manually erased from the memory of the end device before such expiration time.

First-party cookies are cookies that are associated with the domain of the website you are browsing. In our case, these cookies are associated with our engie.sk domain.

Third-party cookies are cookies that are associated with the domain of a website other than you are currently browsing.

Cookie Use Setting

Web browser. You can allow or block the use of cookies by setting up your web browser. The procedure for such setting depends on the web browser you use.

However, blocking the use of all cookies may render some parts of the website inoperable.

Anonymized Website Tracking
